Please follow these steps to apply for a visa to Brazil:

Step 1: Read the "Know your visa type" section of the webpage of the Brazil Visa Application Centre and apply for a visa that suits the purpose of your intended stay in Brazil.

Step 2: Access the online visa request form (<https://formulario-mre.serpro.gov.br>), fill out the visa request form and print the receipt page with bar code.

Step 3: For your convenience, book an appointment at the Brazil Visa Application Centre in China of the jurisdiction of your residence (https://china.blsbrazilvisa.com/book_appointment.php).

Step 4: Bring the documents mentioned in the checklist below to the Brazil Visa Application Centre

步骤三: 为了方便您的签证申请, 您可以在中国巴西签证申请中心网站 (https://china.blsbrazilvisa.com/book_appointment.php) 预约来居住地管辖范围内的签证申请中心提交签证申请。

步骤四: 请携带审核表中所列的材料前往签证申请中心进行签证申请。

The Brazil Visa Application Centre will only receive applications that comply with all the requirements presented below. Incomplete applications will be refused. The Embassy of Brazil/Consulate-General of Brazil reserves the right to request additional documents, information and/or to interview the applicant, as deemed necessary. Providing inaccurate, misleading and/or false information will lead to the denial of your application and prevent you from obtaining visas to Brazil in the future.
