Please follow these steps to apply for a visa to Brazil:

Step 1: Read the "Know your visa type" section of the webpage of the Brazil Visa Application Centre and apply for a visa that suits the purpose of your intended stay in Brazil.

Step 2: Access the online visa request form (https://formulario-mre.serpro.gov.br), fill out the visa request form and print the receipt page with bar code.

Step 3: For your convenience, book an appointment at the Brazil Visa Application Centre in China of the jurisdiction of your residence (https://china.blsbrazilvisa.com/book appointment.php).

Step 4: Bring the documents mentioned in the checklist below to the Brazil Visa Application Centre

Providing inaccurate, misleading and/or false information will lead to the denial of your application and prevent you from obtaining visas to Brazil in the future.
